In consideration of the mutual promises, covenants and conditions contained in the agreement, Camp Bayshore and the undersigned (a parent(s) or legal guardian(s) of the camper named on front page) agree as follows:

**Parent or guardian, please initial each item to indicate agreement**

\_\_\_\_\_ 1. **Registration:** The registration fee for Summer 2010 is **\$35 per child (before June 1) or \$50 (after June 1).**

\_\_\_\_\_ 2. **Tuition:** The weekly tuition for Summer Camp Bayshore 2010 is **\$175 per child.** There will be a **\$25 discount** for subsequent children from the same immediately family.

\_\_\_\_\_ 3. **Payment Terms:** The weekly tuition (\$175 per child) is due no later than the Friday before the week(s) the child will attend camp. **Payment is due for week(s) the parent or guardian has indicated on the Registration Calendar that the child will attend camp, even if the child subsequently does not attend on some of those days for any reason.** If payment is not received by Friday, the camper's place will be considered open for that week, but **payment is still required.**

\_\_\_\_\_ 4. **Refunds and Credits:** No refunds will be given and no credits will be issued for days that a camper was scheduled to attend but did not do so.

\_\_\_\_\_ 5. **Default:** Camp Bayshore reserves the right to dismiss from camp for the rest of the summer any child for whom tuition is not paid according to **Number 3** above.

\_\_\_\_\_ 6. **Integrated Agreement:** This contract constitutes the entire agreement between the parent or guardian and Camp Bayshore. There are no agreements, understanding or representations between the two parties other than those stated in this contract.

\_\_\_\_\_ 7. **Jurisdiction:** Parent or guardian and Camp Bayshore agree that the sole jurisdiction for any legal matter arising out of this agreement will be Hillsborough County, Florida.

\_\_\_\_\_ 8 **Attorney's Fees:** If any legal action is involved in connection with this camper's experience at Camp Bayshore, the prevailing party will be entitled to reasonable attorney's fees and investigatory expenses.
